THE PRESIDENT'S MESSAGE

For the past several years there has been a steady increase of interest in the sport we know as Field Trials.

This increased interest is a wounderful thing to improve the quality and quantity of retrievers through the country,

As with many good things there is a darker side. The large numbers of good dogs qualified to run in open stakes has made the entry lists so large in licensed trials that it is almost impossible to give the dogs a chance to show what they can do. We have seen several exemples this year of open stakes with entries of over fifty dogs. In several cases it has been necessary to complete the stake in one day. Even with good mechanics and relatively short tests, it is improbable that more than three series can be run in one day. This means that a dog running a good sound level trial may be dropped from competition because of the need for speed and not eliminated for faulty work.

There are several dangers in this practice. The most consistent dogs, the ones that can come through in a National Stake, may have real problems in getting qualified. Then, too, owners will soon get discouraged paying the training bills and entry fees just to see their dogs dropped after one or two series. The interest will soon lag to the detriment of our sport.

There are rumors that individual clubs plan to take steps to reduce the entries.

I believe this can only lead to confusion and hard feelings. I believe the problem is one that should be regulated by the National Advisory Board.


