Directions to Bob Hayden's Wood Dale Farm

1400 W. Henry St. Sedalia, MO 65301

Directions

From South KC – Johnson Co.

Take I-435 to I-470 West to 50 Hwy West. When you get to Sedalia go to the intersection of 50 & 65 Hwy. Turn North on 65 and go Approx 1.5 miles to HH. Turn East on HH and go 3 miles to EE. Turn North on EE, 1.6 miles to the "Wood Dale Farm" Sign. Turn left (Iron Gate and Brick posts) Signs will be out.

From I-70 take 65 South to HH and follow the above instructions.

The Super Singles Rules will be as follows:

Dogs 6 Months to 8 yrs, old will be a timed event

For 8 Year old dogs and older it will be a marking event, speed does not count.

PENALTY'S – Under 8 years old there will be a 25 second penalty for cheating the water For the 8+ crowd there will be a 1.5 penalty on the overall score of their mark for cheating.

Entry Fees - \$15.00 for the first dog, \$10.00 for any dog after the first
